1. Introduction

2. What is a cookie?

3. How long do cookies last?

Cookies can remain on your computer or mobile device for different periods of time.

- Some cookies are 'session cookies', which means they only exist when your browser is open and are automatically deleted when you close your browser or quit the app.
- Other cookies are 'persistent cookies', meaning they survive after your browser or app is closed and can be used by Websites or apps to recognize your computer when you re-open your browser or app later. The length of the cookies used on our Website is explained in more detail in the table below.

4. Types of Cookies We Use

Our Website and its partners use five (5) categories of cookies:

Strictly Necessary Cookies: These cookies are strictly necessary to provide you with services available through our Website; they enable core features such as secure login, account management, and compliance with legal and regulatory requirements. As they are required for a normal browsing experience, we inform you about them, and they are automatically stored when you access the Website.

Performance (or analytics) Cookies: These cookies are used to collect data on how visitors interact with our Website. They help us analyze Website traffic and improve its performance by tracking usage patterns and identifying potential issues.

Targeting (or Advertising) Cookies: These cookies are used to deliver relevant advertisements based on your interests and browsing behavior. These cookies help us tailor promotions and marketing messages.

First-party and Third-party Cookies

- **First-party cookies** are set by our website while you browse. These cookies help improve the site's performance and provide you with a better user experience.
- **Third-party cookies** are placed by external parties, such as advertisers or analytics providers. These cookies may be used for online advertising and may collect data subject to the third party's own privacy policies.
